

3	The Unaudited financial results of the Company for the 2nd quarter and half year ended 30th September, 2017 including restated figures for the corresponding year to date results for the period 1st April, 2016 to 30th September, 2016 and for the period 1st April, 2016 to 31st March, 2017 including the reconciliation of profit under Ind AS with profit reported under previous GAAP for comparative year to date for the period 1st April, 2016 to 30th September, 2016, as reported in these financial results have been reviewed by the Audit Committee of the Board and approved by the Board of Directors at their respective meetings held on 7th November, 2017.			
4	The Stand Alone financial results of the Company for the 2nd quarter and half year ended 30th September, 2017 have been subjected to Limited Review by the Statutory Auditors of the Company as required under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the Limited Review Report of the Statutory Auditors is enclosed herewith. This Report does not have any impact on the "Results and Notes " for the 2nd Quarter and half year ended 30th September, 2017 which needs to be explained. The Management has exercised necessary due diligence to ensure that the financial results provide a true and fair view of the results of the operations of the Company.			
5	The Company is operating primarily in the Footwear segment, and as such there are no separate reportable segments.			
6	The above given results do not include the details of Company's overseas WOS at Middle East. This WOS, has not yet commenced its commercial operations, therefore, there are no significant changes in consolidated and standalone results of the Company for the 2nd Quarter and half year ended 30th September, 2017 and the Consolidated Net Profits and EPS remained at Rs. 214.60 Lakh and Rs. 1.26 /- respectively.
